A Comprehensive Sign Program is required when two (2) or more non-exempt signs are proposed for a new or existing development or if a joint identification sign is proposed. The Planning and Zoning Commission must approve a Comprehensive Sign Program prior to issuance of a Sign Permit by the Zoning Inspector.

This Application does not constitute a Sign Permit or a Building Permit. Following approval of a Comprehensive Sign Program, a Sign Permit for each sign must be issued by the Zoning Inspector. This requires submittal of an Application for a Sign Permit. All signs other than window signs require Building Permits. Contact the Building Department at (614) 409-4407 for additional information regarding Building Permits.

Submit ten (10) full color copies of the Application and all required attachments as well as the required fee at least thirty-five (35) days prior to the Planning and Zoning Commission meeting where the Application will be heard by the Commission.

Non-illuminated sign: \$20 (up to 100 sq ft in area); \$40 (101 to 500 sq ft); \$60 (more than 500 sq ft)
