ORDINANCE: 24-16

PASSED: April 11, 2016

**AN ORDINANCE APPROVING THE RECODIFICATION, EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF OBETZ AND DECLARING AN EMERGENCY**

**WHEREAS**, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of Obetz, Ohio; and,

**WHEREAS**, numerous sections in the Traffic, General Offenses and Fire Prevention Codes need to be updated to reflect legislation enacted by the Ohio General Assembly;

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:**

Section 1. That the recodification, editing, arrangement and numbering or renumbering of the ordinances and parts of ordinances of the Village of Obetz are hereby approved as parts of the various component codes of the Codified Ordinances of Obetz, Ohio, as set forth in the 2016 Replacement Pages so as to conform to the classification and numbering system of the Codified Ordinances.

Section 2. The following sections of the Traffic and General Offenses Codes, as amended, are hereby approved and adopted as amended or enacted so as to conform to enactments of the Ohio General Assembly.

Notice of adoption of each new section by reference to its title shall constitute sufficient publication of new matter contained therein.

Section 4. This Ordinance shall is hereby declared to be an emergency measure, necessary for the preservation of the public health, safety and welfare, such emergency arising from the need to update the Codified Ordinances to reflect local legislation and the State traffic and criminal law changes that have taken effect in the last year.
