AN ORDINANCE AMENDING SECTION 509.10 OF THE VILLAGE OF OBETZ CODIFIED ORDINANCES TITLED "DISTURBING THE PEACE"

WHEREAS, a violation for disturbing the peace is a minor misdemeanor which is punishable by a fine only; and,

WHEREAS, the Village in interested in implementing a penalty system that will discourage repeat violations.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:

Section 1. Section 509.10 is hereby amended as follows:

509.10 DISTURBING THE PEACE.

- (a) No person shall erect, continue, use or maintain a building, structure, or place for the exercise of a trade, employment or business or for the keeping or feeding of an animal, which disturbs the good order and quiet of the Municipality. No person shall disturb the peace by any clamor or noise, the ringing of gongs for advertising purposes, or by intoxication, drunkenness, fighting, using obscene or profane language in any street or other public place, to the annoyance of any of the residents, or otherwise violate the public peace by indecent and disorderly conduct or by lewd and lascivious behavior.
- (b) Whoever violates this section is guilty of a minor misdemeanor.:

(1) A minor misdemeanor;

- (2) A misdemeanor of the fourth degree for the second offense within 12 months;
- (3) A misdemeanor of the third degree for the third offense within 12 months.

<u>Section 2</u>. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
