ORDINANCE: 35-16 PASSED: May 23, 20/6

AN ORDINANCE APPROVING AN UPDATED PRELIMINARY DEVELOPMENT PLAN FOR THE GATEWAY CAMPUS OF THE RICKENBACKER GLOBAL LOGISTICS PARK

WHEREAS, the Gateway Campus of the Rickenbacker Global Logistics Park is comprised of Franklin County Auditor parcel numbers 152-001919, 152-001918, 152-001920, 152-001921, and 186-000400; and,

WHEREAS, Ordinances 35-07 and 36-07 rezoned the parcels to Planned Industrial District and approved a Preliminary Development Plan; and,

WHEREAS, since that time an additional public roadway was added to the Preliminary Development Plan; and,

WHEREAS, the approval of the updated Preliminary Development Plan is required; and,

WHEREAS, the Planning and Zoning Commission approved the updated Preliminary Development Plan at its April 13, 2016 meeting with the condition that the only curb cuts approved are Gateway Court and Global Court and the curb cuts needed for 6050 Gateway Court; and,

WHEREAS, the Planning and Zoning Commission recommended that future curb cuts onto public roads be evaluated on a case by case basis based on the final design of each site.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:

<u>Section 1.</u> The updated Preliminary Development Plan, attached hereto as Exhibit A and incorporated herein by reference, is hereby approved.

Section 2. The only curb cuts approved as a part of the updated Preliminary Development Plan are Gateway Court, Global Court, and the curb cuts needed for 6050 Gateway Court.

<u>Section 3.</u> Future curb cuts on public roads will be approved by the Planning and Zoning Commission on a case by case basis as a part of the Final Development Plan of each individual site.

<u>Section 4</u>. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
