ORDINANCE: 48 - 16

PASSED: May 23, 2016

AN ORDINANCE WAIVING THE PROVISIONS OF SECTION 157.03 OF THE CODIFIED ORDINANCES FOR THE BRETT COURT ROAD IMPROVEMENTS AND TO DECLARE AN EMERGENCY

WHEREAS, Section 8.02 of the Village Charter outlines the Village's contracting powers and procedures including establishing a competitive bidding threshold; and,

WHEREAS, Section 8.02 of the Village Charter also allows Council to waive, by a vote of 5 Members, the competitive bidding requirement when it is in the best interest of the Village to do so; and,

WHEREAS, there is standing water on Brett Court which has led to heaving pavement and curb deterioration; and,

WHEREAS, in the winter the standing water freezes on the roadway creating a hazard;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:

Section 1. Village Council hereby waives the provisions of Section 157.03 of the Codified Ordinances for the Brett Court Road Improvements which will include additional storm sewers, curb replacement, and pavement repair as such a waiver is in the best interest of the Village.

Section 2. Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health and safety of the Village, such emergency arising from the Village's immediate need to move forward during this construction season before the onset of winter; WHEREFORE, this Ordinance shall take effect and be in force immediately upon passage by Council.
