AN ORDINANCE AUTHORIZING THE FINANCE DIRECTOR TO EXPEND FUNDS TO SETTLE A CLAIM BY STEVE AND MELISSA HICKS, AND DECLARING AN EMERGENCY

WHEREAS, in September 2016, the Village of Obetz believes a water valve was closed too quickly by an employee, resulting in damage to plumbing at 4469 Butler Farms Drive; and,

WHEREAS, the cost to the Steve and Melissa Hicks to repair the damage incurred as a result of the closed valve totaled \$4407.73; and,

WHEREAS, the Ohio Supreme Court recognizes the authority of a municipality to enact legislation for the payment of a claim which is unenforceable by law against it but which principles of justice and equity constitute a moral obligation of the municipality; and,

WHEREAS, the Village of Obetz recognizes its moral obligation to reimburse Steve and Melissa Hicks for their costs;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:

Section 1. The Fiscal Officer is hereby authorized and directed to pay Melissa Hicks the sum of \$500.00; and the subrogation unit EXL Service, acting on behalf of USAA Insurance, the sum of \$3907.73. Melissa Hicks is solely responsible for the remaining portion of any expenses, and payment of any and all taxes, including penalties and interest, which might be determined to be owed on these amounts.

<u>Section 2.</u> The Village Administrator is hereby authorized and directed to enter into and execute a Release of Claims in substantially the same format and content as the document attached hereto as Exhibit A and incorporated herein by reference.

Section 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the Village of Obetz which resulted in formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 4. All prior Ordinances, or any parts thereof, which is/are inconsistent with this Ordinance is/are hereby repealed as to the inconsistent parts thereof.

Section 5. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the Village and for the further reason that the Village must resolve this claim as soon as possible to avoid additional and unnecessary costs, expenses, and fees; WHEREFORE, this Ordinance shall take effect and be in force from and after its passage.
