

# VILLAGE OF OBETZ RECORD OF PROCEEDINGS

#### **REGULAR MEETING OF MARCH 25, 2013**

The Obetz Village Council met in regular session on March 25, 2013 at 6:00 PM in Council Chambers with Mayor D. Greg Scott presiding.

#### **Roll Call**

Mayor Scott called the roll with five members of Council present: Mrs. Bonnie Wiley, Mr. James Wiley, Mr. John Souders, Mr. Michael Flaherty, and Mrs. Louise Crabtree. Mr. Triplett was absent. Also present were E. Rod Davisson, Administrator; Eugene Hollins, Solicitor; Andrew Gamblin, Police Sergeant; and, Stacey Boumis, Community Services Director/Council Clerk.

# **Standing Committee Reports**

Recreation and Health – Mr. Souders stated that 110 bags were given out at the Easter Egg Hunt. A recent athletics magazine features several Obetz trainers. There is a mandatory baseball and softball meeting in the Obetz gym at the Community Center. Obetz will be joining the Teays Valley league for both softball and baseball.

Safety and Streets – Mayor Scott stated that the Street Department has done a good job keeping the streets cleared. Mrs. Scott stated from the audience that she is concerned about the bike path stop sign near Maureen Boulevard.

Planning and Zoning Commission – Mrs. Wiley stated that she would like to have a bounty on coyotes. Mr. Davisson, Mayor Scott, and Council discussed coyote related issues and safety. Mrs. Wiley stated that coyotes are the number one safety issue in Obetz.

## **Village Officials' Reports**

Mayor Scott – Mayor Scott stated Matt Cramblit has been hired as the full time IT Director. Kevin Hall has been hired and will start with the Street Department on April 15. The Village is evaluating the condition of pavement in order to determine which streets will be paved in 2013. The catch basin at Obetz Avenue will also be repaired in 2013. The Obetz Conference Center is nearing completion and the Zucchinifest is five months away.

Mrs. Sharon Jones stated that semi-trucks continue to go down Bridlewood Boulevard. The trucks are tearing up the speed bumps. The Village needs an ordinance limiting trucks on interior streets. Council, Mayor Scott, and Mr. Davisson discussed this issue.

Eugene Hollins, Solicitor – Mr. Hollins thanked Council for authorizing the purchase of the Ryan property.

Andrew Gamblin, Police Sergeant – Sergeant Gamblin stated that Chief Hinkle was on vacation. There were no questions for Sergeant Gamblin.

Stacey Boumis, Council Clerk - Nothing to report.

E. Rod Davisson, Esq., Administrator – Mr. Davisson stated the new Zucchinifest website will be up soon. He announced that Bret Michaels will be the headliner on Saturday. Mr. Davisson discussed the improvements to the water treatment plant and the quality of water.
