**REGULAR MEETING OF AUGUST 12, 2013**

The Obetz Village Council met in regular session on August 12, 2013 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Mayor D. Greg Scott presiding.

**Roll Call**

Rod Davisson, Administrator/Economic Development Director; Kenneth Hinkle, Chief of Police; Eugene Hollins, Solicitor; and, Stacey Boumis, Community Services Director/Council Clerk.

*Kenneth Hinkle, Police Chief* – Chief Hinkle stated that he will continue to monitor Lancaster Street to ensure traffic is obeying the new stop signs. Officers recently completed active shooter training. Pelatonia went well. School also starts Monday.
