

VILLAGE OF OBETZ RECORD OF PROCEEDINGS

REGULAR MEETING OF JULY 22, 2013

The Obetz Village Council met in regular session on July 22, 2013 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Mayor D. Greg Scott presiding.

Roll Call

Mayor Scott called the roll with six members of Council present: Mrs. Bonnie Wiley, Mr. James Wiley, Mr. Michael Flaherty, Mr. John Souders, Mrs. Louise Crabtree, and Mr. James Triplett. Also present were E. Rod Davisson, Administrator/Economic Development Director; Kenneth Hinkle, Chief of Police; Eugene Hollins, Solicitor; and, Stacey Boumis, Community Services Director/Council Clerk.

Approval of Minutes

Mr. Davisson stated that the public hearing will occur at the next meeting. Mayor Scott called for a motion to table. Motion made by Mr. Wiley; seconded by Mrs. Wiley. Ms. Boumis read Ordinance 45-13 An Ordinance Authorizing The Provision Of Certain Incentives For Purposes Of Encouraging The Relocation To The Village By Avnet, Inc., Which Include The Provision Of A Municipal Income Tax Credit Authorizing The Execution Of A Municipal Income Tax Credit Agreement, And Declaring An Emergency. Mr. Davisson discussed Ordinance 45-13. TJ Harper, an Avnet, Inc. representative, addressed Council. He stated this will be Avnet Inc.'s largest facility in North America. Mayor Scott called for a motion to suspend the rules regarding the adoption of Ordinance 45-13. Motion made by Mr. Triplett; seconded by Mr. Wiley. Voting as follows: Mrs. Wiley – yes; Mr. Wiley – yes; Mr. Flaherty– yes; Mr. Triplett – yes; Mrs. Crabtree – yes; Mr. Souders – yes. Mayor Scott called for a motion to adopt Ordinance 45-13. Kenneth Hinkle, Police Chief – Chief Hinkle stated that Alum Creek Drive/Groveport Road is now open. He further stated that Pelotonia will be traveling through Obetz on August 10th.

E. Rod Davisson, Esq., Administrator/Economic Development Director – Mr. Davisson discussed the status of current Village projects. Mr. Triplett thanked Mr. Davisson for painting the light poles on Dexter Court.

Remarks from the Audience

Jerry Benson addressed Council and the Mayor. He stated that he wants the Village to park Village owned vehicles on the Obetz Avenue side of the Obetz Conference Center. Next he stated that he does not want the location of Obetz Junction removed. It is close to where the gazebo is now. Then he stated that traffic is cutting through the internal streets in west Obetz. In closing he stated that he is not happy with the design of the Alum Creek Drive/Groveport Road intersection. Mr. Davisson, Council, and Mayor Scott discussed several of the above issues.

Bob Jones addressed Council and the Mayor. He commended them as well as the Administration for installing the Lancaster Road stop signs and building the splash pad. He suggested that the pedestrian walkway be striped.

Kay Peters addressed Council and the Mayor. She stated that people are speeding up and down her street. She stated that additional stop signs need installed in her neighborhood. She further stated that she has not seen increased law enforcement. Chief Hinkle stated that monitoring has increased in her neighborhood. The officers are not visible because they are in unmarked cars.
