REGULAR MEETING OF JUNE 10, 2013

The Obetz Village Council met in regular session on June 10, 2013 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Mayor D. Greg Scott presiding.

Roll Call

Mayor Scott called the roll with six members of Council present: Mrs. Bonnie Wiley, Mr. James Wiley, Mr. Michael Flaherty, Mr. John Souders, Mrs. Louise Crabtree and Mr. James Triplett. Also present were Brandon Abshier, Solicitor; Kenneth Hinkle, Police Chief; E. Ms. Boumis read Ordinance 29-13 An Ordinance To Enact Section 181.021 Of The Codified Ordinances Of The Village Of Obetz To Increase In The Village Income Tax Rate From The Current Rate Of Two Percent (2.0%) To A Rate Of Two And One-Half Percent (2.5 %) To Become Effective On January 1, 2014 For The Purposes Of Public Safety Including, But Not Limited To, Police Services, And Related Costs Of The Village And Declaring An Emergency.

Ms. Boumis read Ordinance 30-13 A Ordinance Providing For The Submission To The Electors Of The Village Of Obetz, At The General Election To Be Held On November 5, 2013, An Ordinance To Enact An Increase In The Village Income Tax Rate From The Current Rate Of Two Percent (2.0%) To A Rate Of Two And One-Half Percent (2.5%) To Become Effective On January 1, 2014, For The Purposes Of Public Safety Including, But Not Limited To, Police Services, And Related Costs Of The Village. The Parks and Recreation staff has begun cleaning up the Anderson property. The eviction of the Ryan house tenants has gone through the court system. The Village has received quotes to demolish the Magoffin Drive and Ryan houses. The Magoffin Drive house will be demolished first.

Kenneth Hinkle, Police Chief – Chief Hinkle stated the west side roundabout has opened. Citations are up which is typically in warmer weather. On June 22nds the intersection of Alum Creek Drive and Groveport Road will be closed from 7:00 AM to 7:00 PM.
