

VILLAGE OF OBETZ RECORD OF PROCEEDINGS

REGULAR MEETING OF JUNE 24, 2013

The Obetz Village Council met in regular session on June 24, 2013 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Mayor D. Greg Scott presiding.

Roll Call

Ms. Boumis read Ordinance 33-13 An Ordinance To Adopt The Tax Budget For The Village Of Obetz, Ohio For The Fiscal Year Beginning January 1, 2014 And To Submit The Same To The Franklin County Budget Commission And To Declare An Emergency.

Ms. Boumis read Ordinance 37-13 An Ordinance To Amend Sections 1133.02, 1143.05, 1165.08, And 1173.02 Of The Codified Ordinances; Delete Sections 1135.06, 1138.03, 1139.03, 1141.03, 1142.03, And 1143.03 Of The Codified Ordinances; Create Chapter 1171 In The Codified Ordinances; Delete Chapter 1177 Of The Codified Ordinances; And To Declare An Emergency.

Ms. Boumis read Ordinance 39-13 An Ordinance To Provide For The Transfer Of Funds From The Toy Road TIF Construction Fund, The Alum Creek Drive Land Acquisition Fund, The Alum Creek Drive Columbus Reimbursement Fund And The Alum Creek Drive/Toy Road Intersection Fund To The General Obligation Bond Retirement Fund.
