## AN ORDINANCE TO ESTABLISH THE OPWC FRUSTA/MCGAW GRANT FUND, APPROPRIATE FUNDS, AND AUTHORIZE AN ADVANCE FROM THE GENERAL FUND

WHEREAS, the Village of Obetz received approval of a grant and a loan from the Ohio Public Works Committee (OPWC) in the amount of \$1,999,600 for the reconstruction of Frusta Drive and McGaw Road within the Obetz Industrial Park; and,

WHEREAS, the State of Ohio requires the establishment of a new fund in order to account for the grant and loan whose use is restricted to a particular purpose; and,

WHEREAS, Council needs to appropriate the funds for the project; and,

WHEREAS, an advance from the General Fund is needed to pay obligations of the project until the grant and loan proceeds are received;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, STATE OF OHIO, THAT:

<u>Section 1</u>: There is hereby established the OPWC Frusta/McGaw Grant Fund, as a capital projects fund of the Village, to account for a grant from the OPWC the grant and loan proceeds from which are to be used for the reconstruction of Frusta Drive and McGaw Road within the Obetz Industrial Park.

<u>Section 2</u>: The following funds are hereby appropriated in the OPWC Frusta/McGaw Grant Fund:

Capital Outlay

\$1,999,600

<u>Section 3.</u> For the purpose of providing funds for OPWC Frusta/McGaw Grant Fund, the amount of \$175,000 be and is hereby advanced from the General Fund. The amount is solely an advance, and is not as a transfer. The advance shall be repaid as the grant and loan proceeds become available and after the obligation of the project are met.

<u>Section 4</u>: This ordinance shall take effect at the earliest opportunity allowed by law.
