ORDINANCE: 14-14

PASSED: March 24, 2014

**AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO APPLY FOR A GRANT FROM THE LOCAL GOVERNMENT INNOVATION FUND AND ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE OTHER GRANT CO-APPLICANTS AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Village of Obetz wishes to study the feasibility and possible route of a fiber optic system; and

**WHEREAS**, the Village of Obetz and the other co-applicants entered into a Memorandum of Understand, a copy of which is on file with the Director of Law; and

**WHEREAS**, grant funds for such feasibility routing studies are available from the Local Government Innovation Fund; and

**WHEREAS**, the Village of Obetz desires to apply for a grant from the Local Government Innovation Fund; and

**WHEREAS**, the Village of Obetz and the co-applicants have jointly agreed in principle to examine the feasibility and routing of a fiber optic system.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO THAT:**

Section 1: The Mayor or Administrator is authorized to execute such documentation as is necessary or required for purposes of submission of a grant from the Local Government Innovation Fund in order to examine the feasibility and routing of a fiber optic system.

Section 2: The Memorandum of Understanding is hereby approved and authorized with changes therein not inconsistent with this Ordinance and not substantially adverse to this Village and which shall be approved by the Director of Law.

Section 3: Council declares this to be an emergency measure, the immediate passage of which is necessary for the preservation of the public peace, health, safety, and welfare of the Village of Obetz, such emergency arising from the imminent filing deadline for applications; WHEREFORE, this Ordinance shall take effect and be in force immediately upon passage by Council.
