ORDINANCE: 30-14

PASSED: June 9, 2014

AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO ADVERTISE FOR BIDS AND TO AWARD A CONTRACT TO THE LOWEST AND BEST BIDDER FOR THE FRUSTA/MCGAW ROAD RECONSTRUCTION AND TO DECLARE AN EMERGENCY.

WHEREAS, the Village of Obetz is located within Franklin County, State of Ohio, and

WHEREAS, the Village has received funding from the Ohio Public Works Commission in the amount of \$1,497,629 for the completion of the Frusta/McGaw Roads Reconstruction Project (the "Project"); and

WHEREAS, the total estimated cost for this phase of the project is \$1,999,505.00 dollars the balance of which shall be covered by a loan from OPWC, and

WHEREAS, the cost for this project has been appropriated within the 2014 budget along with the Village's local share of this Ohio Public Works Commission Grant, and

WHEREAS, this Project needs to be completed as soon as possible to meet the requirements of OPWC and the needs of the traveling public; and

WHEREAS, The Village Engineer with the assistance of EMH&T has and/or shall prepare the plans, preliminary engineering, preparation of detail construction, bidding process, inspection of construction and other miscellaneous services for this project; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:

Section 1. The Village Administrator is authorized to advertise for bids and to award a contract to the best and lowest bidder in accordance with the laws of the Village of Obetz and requirements of Ohio Public Works Commission for the Project.

Section 2. The Fiscal Officer is hereby authorized to spend from the OPWC Frusta McGraw Grant Fund Appropriations, Fund Number 4908-800-555, a total of \$1,999,600 for this improvement project.

ORDINANCE: 30-14

PASSED: June 9, 2014

Section 3. This Ordinance is declared an emergency and shall take effect at the earliest time permitted by law. The reason for the emergency is to provide for the health, safety, and welfare of the citizens of the Village of Obetz. Specifically, the Village must immediately move forth with the bidding process in order to complete the Project for the safety of the traveling public.
