**ORDINANCE: 35-14**

**PASSED:** June 23, 2014

**AN ORDINANCE TO APPROVE ADDITIONAL 2014 APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF OBETZ.**

**WHEREAS**, Ordinance Number 69-13, approved the 2014 appropriations for the current expenses and other expenditures of the Village; and

**WHEREAS**, the Village Council has authorized the sale of notes in the anticipation of bonds for the improvement and expansion of the electric distribution system; and,

**WHEREAS**, these appropriations are to be effective for the year ending December 31, 2014.
