

VILLAGE OF OBETZ RECORD OF PROCEEDINGS

REGULAR MEETING OF FEBRUARY 10, 2014

The Obetz Village Council met in regular session on February 10, 2014 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Mayor D. Greg Scott presiding.

ROLL CALL

E. Rod Davisson, Esq., Administrator/Economic Development Director – Mr. Davisson stated that Obetz had a great year economically. In order for the Village to maintain its bond rating, it needs to keep \$1.7 million dollars in the bank. He shared his capital spending recommendations with Council. Mayor Scott and Council members commented on the list.

Mr. Davisson discussed the I-270 project showing a preliminary design for the interchange and bridge. He also discussed water shut-offs at vacant properties and pot hole claims. Council members determined they were not interested in paying the claims Mr. Davisson presented.

Mr. Davisson discussed the improvements to Frusta Drive and McGaw Road. He stated that the Village received a grant to defer a portion of the cost. He also discussed the Toy Road curb cut requested by Opus. He stated that he wanted to trade this curb cut for a curb cut onto Rohr Road.

Mr. Davisson stated that Council will need to determine the next big project. He presented four choices – the indoor sports arena; indoor hard court; downtown revitalization; outdoor public pool. He further stated that the archery range and swimming pond can be developed in addition to the above projects. Council members and Mayor Scott discussed future projects.
