

# VILLAGE OF OBETZ RECORD OF PROCEEDINGS

### **REGULAR MEETING OF JUNE 9, 2014**

The Obetz Village Council met in regular session on June 9, 2014 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Mayor D. Greg Scott presiding.

#### **ROLL CALL**

Mayor Scott called the roll with five members of Council present: Mrs. Bonnie Wiley, Mr. James Wiley, Mr. Guiles Richardson, Mrs. Angie Kirk, and Mr. Michael Flaherty. Also present were E. Rod Davisson, Administrator, Michael Confer, Chief of Police; Eve M. Ellinger, Law Director, and, Stacey Boumis, Community Services Director/Council Clerk.

Mayor Scott called for a motion to excuse Mrs. Louise Crabtree. Motion made by Mr. Richardson; seconded by Mr. Flaherty. Voting as follows: Mrs. Wiley – no; Mr. Wiley – no; Mr. Richardson – no; Mr. Flaherty – no; Mrs. Kirk – no. Motion failed.

#### **APPROVAL OF MINUTES**

Mayor Scott called for a motion to approve the minutes of the regular meeting of May 27, 2014. Motion made by Mrs. Wiley; seconded by Mr. Wiley. Voting as follows: Mrs. Wiley – yes; Mr. Richardson – yes; Mr. Flaherty – yes; Mrs. Kirk – yes. The minutes of the May 27, 2014 meeting were approved.

### **Second Readings**

Ms. Boumis read Ordinance 24-14 An Ordinance Reauthorizing An Agreement Between The Village Of Obetz And The Board Of County Commissioners, Franklin County, Ohio On Behalf Of The Village Of Obetz In Order To Participate In The Franklin County, Ohio Department Of Housing & Urban Development (HUD) Entitlement Program. Mr. Davisson reviewed Ordinance 24-14. Mayor Scott, Council, and Mr. Davisson discussed the Ordinance.

Ms. Boumis read Ordinance 25-14 An Ordinance To Enact Section 181.021 Of The Codified Ordinances Of The Village Of Obetz To Increase In The Village Income Tax Rate From The Current Rate Of Two Percent (2.0%) To A Rate Of Two And One-Half Percent (2.5%) To Become Effective On January 1, 2015 To Provide For Police Services And Operations And Declaring An Emergency. Mr. Davisson reviewed Ordinance 25-14. He explained how cities in Ohio are

funded. He discussed how townships and school districts are founded. He explained how income tax reciprocity works. He also stated that the proposed levy would generate approximately one million dollars a year in revenue.

Ms. Boumis read Ordinance 26-14 An Ordinance Providing For The Submission To The Electors Of The Village Of Obetz, At The General Election To Be Held On Tuesday, November 4, 2014, An Ordinance To Enact An Increase In The Village Income Tax Rate From The Current Rate Of Two Percent (2.0%) To A Rate Of Two And One-Half Percent (2.5%) To Become Effective On January 1, 2015, For The Purposes Of Police Services And Operations. Mr. Davisson reviewed Ordinance 26-14.

Ms. Boumis read Ordinance 27-14 An Ordinance Adopting Obetz Code Section 905.11 Regarding Grass Clippings And Foliage And Declaring An Emergency. Mayor Scott reviewed Ordinance 27-14. Council discussed Ordinance 27-14.

#### **STANDING COMMITTEE REPORTS**

Recreation and Health (Council Member Kirk) — Mrs. Kirk stated that the splash pad is open from 10 AM to 8 PM daily. She stated that there will be an attendant on-site Friday evening, Saturday, and Sunday. She discussed the policy regarding disruptive behavior. Individuals will be asked to modify behavior three times before they will be asked to leave for the day. She stated that parents do not watch their children.

Safety and Streets (Council Member Crabtree) – Mrs. Crabtree was absent. Mr. Davisson stated that he wants to increase the fine for littering. Mrs. Kirk inquired about the status of the jake brake signs.

Public Utilities (Council President Pro-Tem Flaherty) – Mr. Flaherty discussed the proposed increases in utility rates this year. He stated that the sewer rate and trash rate will both be increased. These increases are a result of increases by the City of Columbus and Waste Management.

Legislation (Council Member Richardson) - Nothing to report.

Planning and Zoning Commission (Council Member B. Wiley) – Mrs. Wiley stated that there will be a Planning and Zoning Commission meeting on June 11<sup>th</sup>.
