ORDINANCE: 32-14

PASSED: July 28, 2014

AN ORDINANCE REPEALING OBETZ CODE SECTION 139.08 AND MODIFYING OBETZ CODE SECTION 139.09.

WHEREAS, the Village of Obetz provides a quality workplace for its employees; and,

WHEREAS, all Village employees should be treated equally; and,

WHEREAS, the Village of Obetz ensures that departments are managed effectively and efficiently; and,

WHEREAS, the position of captain is not necessary in the chain of command of the Police Department.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:

Section 1: Section 139.08 of the Codified Ordinances of the Village of Obetz is hereby repealed.

~~139.08 SEPARATION FROM OTHER EMPLOYEES.~~

~~(a) The Police Department employees shall be separated from other Village employees in matters of salaries, benefits and working conditions.~~

~~(b) All existing benefits and salaries shall remain in place at this time.~~

Section 2: Section 139.09 of the Codified Ordinances of the Village of Obetz is hereby adopted to read as follows:

139.09 CHAIN OF COMMAND.

~~(a)~~ The chain of command within the Obetz Police Department shall be as follows:

- (1) Police Chief.
- ~~(2) Captain.~~
- ~~(3)~~ (2) Lieutenant.
- ~~(4)~~ (3) Sergeant.
- ~~(5)~~ (4) Police Officer.

~~(b) All promotions within the Police Department shall be subject to approval of Council.~~

~~(c) Salaries for each position shall be subject to approval of Council.~~

Section 2. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
