ORDINANCE: 25-14

PASSED: November 10, 2014

AN ORDINANCE TO ENACT SECTION 181.021 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF OBETZ TO INCREASE IN THE VILLAGE INCOME TAX RATE FROM THE CURRENT RATE OF TWO PERCENT (2.0%) TO A RATE OF TWO AND ONE-HALF PERCENT (2.5 %) TO BECOME EFFECTIVE ON JANUARY 1, 2015 TO PROVIDE FOR POLICE SERVICES AND OPERATIONS AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO THAT:

Section 1. Effective January 1, 2015, Section 181.021 of the Codified Ordinances of the Village of Obetz is hereby enacted to read as follows:

181.021 ADDITIONAL TAX

Effective January 1, 2015, in addition to the tax imposed by Section 181.02, there is levied an additional tax of one-half percent (0.5%) per annum upon those classes of salaries, wages, commissions, rent, compensation and profits set forth in Section 181.02, subsections (a), (b), (c), (d), (e), (f), (g) and (h), to provide for police services and operations.

Section 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

Section 3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, and safety of the Village and for the further reason that the additional tax of one-half percent (0.5%) tax provided for herein is pursuant to the approval of the electors of the Village and is to be effective January 1, 2015, in order to provide funding necessary for police services and operations and related costs; WHEREFORE, this Ordinance shall take effect and be in force from and after its passage.
