AN ORDINANCE AUTHORIZING THE VILLAGE TO ENTER INTO A GRANT AGREEMENT WITH THE STATE OF OHIO IN ORDER TO ACCEPT GRANT MONEY FROM THE LOCAL GOVERNMENT INNOVATION FUND AND DECLARING AN EMERGENCY

WHEREAS, Ordinance 14-14 authorized the Village Administrator to apply for a grant from the State of Ohio's Local Government Innovation Fund (LGIF) in order to study the feasibility and possible route of a fiber option system; and,

WHEREAS, the Village of Obetz was awarded a Fifty Thousand Dollar (\$50,000) grant for the Rickenbacker – Southern Franklin County Fiber Network Project; and,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ THAT;

<u>Section 1</u>. The Mayor or Administrator is authorized to enter into a grant agreement – agreement number OERG15-016 – with the State of Ohio in order to accept monies from the Local Government Innovation Fund.

Section 2. The Fiber Network Study Fund (Fund #4910) is hereby created to account for the grant funds.

<u>Section 3.</u> Eleven Thousand Dollars (\$11,000) – the Village's required match – is transferred from the General Fund to the Fiber Network Study Fund.

<u>Section 4</u>. This Ordinance shall be declared an emergency necessary for the public health, safety and welfare of the citizens of the Village of Obetz, such emergency arising from the need to expedite the feasibility study in order to meet grant deadlines; WHEREFORE, this Ordinance shall take effect and be in force from and after its passage.
