PASSED: November 10, 2014

AN ORDINANCE TO APPROVE ADDITIONAL 2014 APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF OBETZ

WHEREAS, Ordinance Number 69-13, approved the 2014 appropriations for the current expenses and other expenditures of the Village; and

WHEREAS, additional appropriations to the 2014 appropriations are required for the payment of certain obligations;
