ORDINANCE: 63-14

PASSED: November 10, 2014

AN ORDINANCE TO AMEND THE 2014 APPROPRIATIONS WITHIN THE GENERAL FUND

WHEREAS, the Village desires to amend the 2014 General Fund appropriations; and,

WHEREAS, the Village desires to reallocate rather than to increase existing appropriations; and,

WHEREAS, Ordinance Number 69-13 approved the 2014 appropriations for the current expenses and other expenditures of the Village;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:

Section 1. The 2014 appropriations be and are hereby amended by changing the appropriations as set forth below:
