ORDINANCE: 67-14

PASSED: December 8, 2014

AN ORDINANCE CREATING THE DEPARTMENT OF ENGINEERING, THE DEPARTMENT OF PARKS AND RECREATION, AND THE DEPARTMENT OF COMMUNITY SERVICES, AND ESTABLISHING THE POSITIONS OF DIRECTOR OF ENGINEERING, DIRECTOR OF PARKS AND RECREATION, AND DIRECTOR OF COMMUNITY SERVICES AND DECLARING AN EMERGENCY.

WHEREAS, the Charter for the Village of Obetz was adopted by the electors at an election on November 3, 2009; and

WHEREAS, the Charter sets forth requirements for Council to formally create certain departments and departmental positions; and

WHEREAS, there is a need for the Village of Obetz to create the Department of Engineering, the Department of Parks and Recreation, and the Department of Community Services;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, STATE OF OHIO, THAT:

Section 1. Pursuant to Section 6.06(A) of the Charter for the Village of Obetz, Council hereby creates the Department of Engineering, the Department of Parks and Recreation, and the Department of Community Services.

Section 2. Pursuant to Section 6.06(A) of the Charter for the Village of Obetz, Council establishes the positions of Director of Engineering, Director of Parks and Recreation, and Director of Community Services.

Section 3. The Mayor shall take action pursuant to Section 6.06(C) of the Charter for the Village of Obetz and make appointments for each position herein.

Section 6. Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of this municipality and the further reason that the Village desires to create the necessary positions; WHEREFORE, this Ordinance shall take effect and be in force immediately upon passage by Council.
