REGULAR MEETING OF JANUARY 12, 2015

The Obetz Village Council met in regular session on January 12, 2015 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Mayor D. Greg Scott presiding.

Michael Confer, Police Chief – Chief Confer stated that he is working with Eric Fischer and Iron Mountain to resolve issues associated with the outside alarm at the facility.

Stacey E. Boumis, AICP, Community Services Director/Council Clerk — Ms. Boumis stated that Council received notice that Dairyland Express wishes to transfer its liquor license. Chief Confer stated that the name of the corporation is changing but ownership is not. There were no objections to the transfer.

E. Rod Davisson, Esq., Administrator/Economic Development Director — Mr. Davisson stated that he is working on a plan for the park across the street. A cost estimate for the proposed improvements will be presented at the next Council meeting. He further stated that he is working with Columbus to address issues with the odor control facility on Alum Creek Drive.
