ORDINANCE: 01-15

PASSED: January 12, 2015

AN ORDINANCE MODIFYING OBETZ CODE SECTION 351.13 REGARDING EMERGENCY SNOW PARKING AND DECLARING AN EMERGENCY.

WHEREAS, the Village plows the streets during snow events; and,

WHEREAS, it is difficult to plow when cars are parked on the street; and,

WHEREAS, many driveways are too shallow to accommodate the number of vehicles owned by a household; and,

WHEREAS, Council desires to allow cars to be temporarily parked in yards during snow emergencies;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO THAT:

Section 1: Section 351.13 of the Codified Ordinances of the Village of Obetz is hereby adopted to read as follows:

351.13 EMERGENCY SNOW PARKING.

- (a) No person shall park any motor vehicle on the streets of the Municipality when there is a two inch accumulation of snow. Whoever violates section is guilty of a misdemeanor of the fourth degree
- (b) When there is a two inch accumulation of snow, vehicles may be parked temporarily in the front yard of a Village residence. All vehicles parked in the front yard of a Village residence during this time must be removed after the street has been plowed.
- (c) Any vehicle parked in violation of this section shall be towed away and impounded. The owner shall be responsible for the towing and impounding fee.
- ~~(d) Whoever violates this section is guilty of a misdemeanor of the fourth degree.~~

Section 2: Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of this municipality, such emergency arising from the need to adopt revised emergency snow parking standards during this winter season; WHEREFORE, this Ordinance shall take effect and be in force immediately upon passage by Council.
