AN ORDINANCE TO MODIFY SECTION 549.11 RELATED TO THE DISCHARGE OF ARROWS AND OTHER OBJECTS WITHIN THE VILLAGE OF OBETZ.

WHEREAS, Section 549.11 of the Codified Ordinances limits the discharge of arrows and other throwing objects; and,

WHEREAS, Obetz desires to modify the Code to prohibit the discharge of arrows and other throwing objects within the Village unless used in a facility designed for such purpose;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:

Section 1. Section 549.11 shall be amended to read as follows:

549.11 **DISCHARGE OF ARROWS, AIR AND GAS GUNS, MISSILES, SLINGSHOTS, AND OTHER THROWING OBJECTS PROHIBITED.**

(a) No person shall discharge any arrow, cross-bow, air or gas guns, missiles, slingshots or other missile throwing devices within the corporate limits of the Municipality.

~~(b) No person shall throw or cast any stone or any other missile, or discharge any arrow, cross bow, bolt or other contrivance for ejecting, discharging or otherwise throwing any missile, pellet, stone, bolt, metal or other substance capable of causing injury to anyone in or upon any street, alley, park or other public ground, or from or out of any yard, lot or building into any street, alley, park or other public ground, or into or against any public or private building in the Municipality.~~

(b) This section does not apply when arrows, cross-bows, air or gas guns, missiles, slingshots or other missile throwing devices are used in self-defense, in the discharge of official duty, on an archery range designed for such use, or when otherwise lawfully authorized.

~~(b)~~ **(c) Whoever violates this section is guilty of a minor misdemeanor of the fourth degree.**

Section 2. This Ordinance shall take effect at the earliest opportunity allowed by law.
