ORDINANCE: 20-15

PASSED: <u>Hebruary 23, 2015</u>

AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO ENTER INTO A PUBLIC/PRIVATE PARTNERSHIP AGREEMENT WITH INNOSOURCE, INC. TO OPERATE THE OBETZ JOBS PROGRAM AND PROVIDE OTHER RELATED PROFESSIONAL SERVICES AND TO DECLARE AN EMERGENCY

WHEREAS, the Village of Obetz desires to create an employment program that benefits both Village residents and Obetz businesses; and,

WHEREAS, the Village of Obetz desires to enter into a Public/Private partnership in order to take advantage of Innosource's private sector expertise in filling orders for qualified applicants and managing a large-scale vendor management system with respect to the Obetz Jobs Program; and,

WHEREAS, the Obetz Jobs Program will provide Obetz businesses the opportunity to hire residents, improve their workforce, and grow their businesses thus contributing to the tax base of the community as well as the Obetz economy; and,

WHEREAS, the Obetz Jobs Program will also work with the local school districts to connect students to internship opportunities and; ultimately, full-time benefitted employment positions with Obetz companies;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ THAT:

<u>Section 1</u>: The Village Administrator is authorized to enter into a contract with InnoSource, Inc., in a form acceptable to the Administrator, to provide professional services related to the creation of Obetz Jobs for a sum not to exceed \$110,000.

Section 2: Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of the Village, such emergency arising from the Village's immediate need to help Obetz businesses enhance their workforce within the community as well as provide job opportunities to Obetz residents; WHEREFORE, this Ordinance shall take effect and be in force immediately upon passage by Council.
