**REGULAR MEETING OF FEBRUARY 23, 2015**

The Obetz Village Council met in regular session on February 23, 2015 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Mayor D. Greg Scott presiding.

Rod Davisson, Esq., Administrator/Economic Development Director* – Mr. Davisson stated that we have a lot of contracts that we are working on including water meter contracts, Tyler Technology, as well as, numerous other contracts that we are working through during this busy time of year planning for Spring to start.

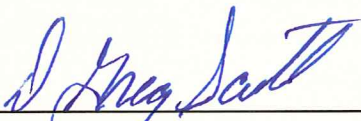
