VILLAGE OFFICIALS' REPORTS

Mayor Scott—Mayor Scott discussed the upcoming Obetz Jobs Council Meeting to be held April 6th, 2015 with Innosource and the local schools. Mr. Davisson added that the Obetz Jobs Council consists of members from the local schools, as well as, local business owners. Topics of discussion will include summer internships and school curriculum, etc. Mayor Scott also gave an update regarding the Dixon Quarry Park and stated that it is not financially feasible at this time for swimming. For now, we will concentrate on the infrastructure, structures, fitness trail, fencing, erosion control and stocking the pond for fishing. Mr. Davisson stated this would give us more time to establish requirements for State licensing in the future.

Eve Ellinger, Esq., Law Director—Ms. Ellinger gave an update on the Obetz Jobs Program. She stated that she and Mr. Beggrow met with Hamilton Local School District regarding the Obetz Jobs Program. She also stated that Mr. Brad Hyslop from InnoSource met with the Eastland/Fairfield Career Center, as well as, Groveport Madison School District regarding the same.

Ms. Ellinger presented two invoices and Mr. Davisson discussed the towing and repair bill that he received from Mr. Brian Eakins totaling \$432.59. Mayor Scott called for a motion to provide payment to Mr. Eakins. Motion made by Mrs. Crabtree; seconded by Mrs. Kirk. E. Rod Davisson, Esq., Administrator/Economic Development Director—Mr. Davisson stated that he had nothing to report other than his absence the previous week due to a heart attack. He is back to work and will be working on CRA reporting this week.
