AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO ENTER INTO CONTRACTS WITH SOUTH CENTRAL POWER COMPANY, AND DECLARING AN EMERGENCY

WHEREAS, the Village of Obetz operates an electric distribution system that services Centerpoint Business Park and Creekside Industrial Park; and

**WHEREAS**, ownership of an electric distribution system is part of a larger plan to enhance the development of the industrial areas by offering, among other things, reliable electric services at competitive prices; and

**WHEREAS**, due to the continued growth in these areas, the Village needs to add capacity to its current system to keep up with demand; and

**WHEREAS**, upgrades to the electric infrastructure are also required in order to meet the demands of the customers; and

**WHEREAS**, Ordinance 38-14 waived the competitive bidding requirements for the upgrades to the electric system; and

WHEREAS, competitive bidding is not required for the purchase of electricity; and

WHEREAS, the Village of Obetz does not generate its own electric; rather, it purchases the electric from South Central Power Company; and

**WHEREAS**, the Village desires to purchase up to twenty thousand (20,000) kilovolt amperes of electric power and energy capacity for resale by the Village through its distribution system and all extensions and additions thereto;

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:

Section 1. The Village Administrator is authorized to enter into a contract with South Central Power Company, in a form acceptable to the Administrator, to purchase an additional 10 megawatts (MW) of capacity, for a sum not to exceed \$1.3 million dollars.

<u>Section 2.</u> The Village Administrator is authorized to enter into a contract with South Central Power Company, in a form acceptable to the Administrator, to make infrastructure improvements to the Obetz Electric System, for a sum not to exceed \$700,000.

<u>Section 3.</u> The Village Administrator is authorized to enter into a five year commodity contract with South Central Power Company, in a form acceptable to the Administrator, to purchase bulk electric for resale.

<u>Section 4</u>. This Ordinance is hereby declared to be an emergency measure, necessary for the preservation of the public health, safety and welfare, such emergency arising from the need to upgrade Obetz' electric distribution system and purchase more capacity in order to serve the current users and attract new businesses to the Village; wherefore, this Ordinance shall take effect and be in force from and after its passage.
