AN ORDINANCE TO REJECT ALL BIDS FOR THE VILLAGE OF OBETZ' GARBAGE AND REFUSE HAULING SERVICES AND PROVIDE FOR A CONTRACTING PROCEDURE FOR GARBAGE AND REFUSE HAULING SERVICES, AND DECLARING AN EMERGENCY

WHEREAS, the Village of Obetz' current contract for garbage and refuse hauling services expires on November 30, 2015; and,

WHEREAS, Ordinance 47-15 authorized the Village of Obetz ("Village") to advertise for bids for garbage and waste hauling services as a part of the Solid Waste Authority of Central Ohio's (SWACO) Trash Consortium 2; and,

WHEREAS, the Village publicly solicited bids for the project as a part of Trash Consortium 2; and,

WHEREAS, the bids for this project were opened and publicly read August 26, 2015 at SWACO's headquarters; and,

WHEREAS, the Village of Obetz reserved its right to "reject any, part of any, or all Bids and to waive any informalities and irregularities" and pursuant to Section 8.02(B) of the Charter, the Village of Obetz may reject any and all bids in whole or by items; and,

WHEREAS, the bid submitted was unacceptable to the Village of Obetz and Obetz desires to reject all bids; and,

WHEREAS, the Council of the Village of Obetz desires to waive competitive bidding and to authorize the Administrator to use the Competitive Bargaining process set forth in Ordinance 08-13 to select a trash contractor; and,

WHEREAS, the Village Council is empowered to enact ordinances for the waiver of competitive bidding in the awarding of contracts by Section 8.02(C) of the Village Charter.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, STATE OF OHIO, THAT:

<u>Section 1</u>: Pursuant to Section 8.02(B) of the Charter for the Village of Obetz, all of the bids for providing garbage and refuse hauling services to the Village of Obetz are hereby rejected.

<u>Section 2</u>. Pursuant to Section 8.02(C) of the Village Charter, Village Council hereby waives competitive bidding with regard to the contract for garbage and waste hauling services. Council hereby empowers the Village Administrator to use the Competitive Bargaining contracting method for the procurement of such services.

Section 3. Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of this municipality, such emergency arising from the Village's immediate need to notify all bidders and determine the next step needed for the Project. WHEREFORE, this Ordinance shall take effect and be in force immediately upon passage by Council.
