ORDINANCE: 70-15

PASSED: October 13, 2015

**AN ORDINANCE TO WAIVE COMPETITIVE BIDDING AND PROVIDE FOR A CONTRACTING PROCEDURE FOR THE VILLAGE OF OBETZ' 2015 STREET PAVING PROGRAM, AND DECLARING AN EMERGENCY**

**WHEREAS**, the Village of Obetz annually paves roads; and,

**WHEREAS**, the Village of Obetz desires to pave Pelham Place, Trotter Drive, and Lisle Avenue this year; and,

**WHEREAS**, the Council of the Village of Obetz desires to waive competitive bidding and to authorize the Administrator to use the Competitive Bargaining process set forth in Ordinance 08-13 to select a contractor for the Village's 2015 street paving program; and,

**WHEREAS**, the Village Council is empowered to enact ordinances for the waiver of competitive bidding in the awarding of contracts by Section 8.02(C) of the Village Charter.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, STATE OF OHIO, THAT:**

Section 1: Pursuant to Section 8.02(C) of the Village Charter, Village Council hereby waives competitive bidding with regard to the contract for street paving. Council hereby empowers the Village Administrator to use the Competitive Bargaining contracting method for the procurement of such services.

Section 2. Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of this municipality, such emergency arising from the Village's immediate need to notify start the project before the end of the paving season. WHEREFORE, this Ordinance shall take effect and be in force immediately upon passage by Council.
