## **REGULAR MEETING OF OCTOBER 13, 2015**

The Obetz Village Council met in regular session on October 13, 2015 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Mayor D. Greg Scott presiding.

### **ROLL CALL**

Mayor Scott called the roll with six members of Council present: Mrs. Bonnie Wiley, Mr. James Wiley, Mr. Guiles Richardson, Mr. Mike Flaherty, Mrs. Louise Crabtree, and Mrs. Angela Kirk. Also present were E. Rod Davisson, Administrator; Eve M. Ellinger, Law Director; Michael Confer, Police Chief, Stacie Garvine, Assistant Development Director, and Stacey Boumis, Community Services Director/Clerk of Council.

# **APPROVAL OF MINUTES**

He explained that the Village joined SWACO's trash consortium 2 in order to get pricing. The pricing received from those bids is where Obetz is now. That pricing is based on separate curbside recycling and yard waste pick-up. Mrs. Kirk stated that she wants to see pricing with and without recycling. ### STANDING COMMITTEE REPORTS

Recreation and Health—Mrs. Kirk stated that Mr. Beggrow is reviewing the ice rink rules and the proposed changes to the rules will be ready for review at the first meeting in November.

## **VILLAGE OFFICIALS' REPORTS**

Mayor Scott—Mayor Scott stated that he needs the Councils' names for the Citizens Utility Committee. He further stated that the ramp at Dixon Quarry is 98% complete. He announced the date and time of the Village Halloween Party. He announced the Mayor's Business Breakfast and Golf Outing which are both scheduled for October 23<sup>rd</sup>. He also stated that the time of Beggar's Night was changed to 5:30 to 7:00 PM.

Eve Ellinger, Esq., Law Director—Ms. Ellinger stated that there are 225 job openings on the Obetz Jobs website. Sixty-one residents have gotten jobs as a result of the program.

Michael Confer, Police Chief—Chief Confer stated that eighty-four pounds of marijuana were recovered from a house in Obetz. Officer Baker arrested the individual that robbed Donatos.

Hamilton Township Fire Department—Chief Shillingburg stated that the Department has been very busy. They had two garage fires — one on Graves and one on Orchard Lane. Also, there was a truck that had overturned on Alum Creek Drive. The annual spaghetti dinner will be on November 5<sup>th</sup>.

Stacey Boumis, Community Services Director—Ms. Boumis stated that there is a Planning and Zoning Commission meeting tomorrow, October 14<sup>th</sup>.

E. Rod Davisson, Administrator—Mr. Davisson stated that water meter replacement is going well. Shortly there will be a time when if residents have not changed out their meter, they will not get water. The new meters will enable the Village to bill in ten gallon increments.

### **NEW BUSINESS**

The resident living at 2340 Maureen Boulevard South addressed Council (name not provided; she was speaking from the audience and not at the podium). She stated that her property was being overrun by roaches as a result of the trailer at 2333 Maureen Boulevard North. Tammy McFarland addressed Council. She stated that she owns several trailers in the area and that two of her properties are also being overrun by roaches. She stated that a year ago she complained to Eric Fischer and nothing was done. She has had to pay to get the properties exterminated. She wants Obetz to be held accountable for what needed done. She stated that someone needs to be liable for damages and that the surrounding property owners want help cleaning up the mess.

Mr. Davisson stated that Mr. Fischer and the intern no longer work for the Village. He further stated that the Village just received the report from the Board of Health on Friday. The property was condemned today. The owner has until November 4<sup>th</sup> to appeal or make the corrections. If they do nothing, the case will go to Mayor's Court.

### REMARKS FROM THE AUDIENCE

Mary Miller addressed Council. She lives on Sandridge Street. She stated that she is having issues getting out of her driveway. Parking needs to be prohibited from the curb to the first driveway. She further stated that there is a lot of littering and junk cars on her street.

Jerry Benson addressed Council. He thanked Amber Graham and Renee Munk for organizing the candidate meet and greet. He thanked Council for installing the basketball hoops at the Community Center. He stated that a resident that lives at the Bixby Grove curb cut to Fairchild Estates is concerned about the overgrowth by an electric box. He is seeking help in getting that area cleaned up.

### **ADJOURNMENT**

Mayor Scott called for a motion to adjourn. Motion made by Mrs. Wiley; seconded by Mrs. Kirk. All ayes. Motion carried. Council adjourned at 7:30 PM.
