REGULAR MEETING OF JANUARY 25, 2016

The Obetz Village Council met in regular session on January 25, 2016 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Mayor D. Greg Scott presiding.

ROLL CALL

Mayor Scott called the roll with six members of Council present: Mrs. Bonnie Wiley, Mr. James Wiley, Mr. Guiles Richardson, Mr. Mike Flaherty, Mrs. Louise Crabtree, and Mrs. Angela Kirk. Also present were E. Rod Davisson, Administrator; Eve M. Ellinger, Law Director; Michael Confer, Police Chief, and Stacey Boumis, Community Services Director/Clerk of Council.

APPROVAL OF MINUTES

ORDINANCES

FIRST READINGS

Ms. Boumis read Ordinance 03-16: An Ordinance Adopting Obetz Code Section 1301.17 Regarding The Requirement For A Foundation Or Slab.

SECOND READINGS

Ms. Boumis read Ordinance 01-16: An Ordinance Authorizing The Mayor To Execute Necessary Conveyance Documentation To Acquire Approximately 0.1377 Acres, More Or Less, Fee Simple Interest From Thelma Deann Moore And Declaring An Emergency. Mr. Davisson discussed Ordinance 01-16. He stated that this parcel is located at the intersection of Maureen Boulevard and Ethel Road. The Village intends to connect Ethel Road to Recreation Trail.

Ms. Boumis read Ordinance 82-15: An Ordinance Approving The Final Plat For The Dedication Of Midpoint Drive. Mr. Davisson discussed Ordinance 82-15. STANDING COMMITTEE REPORTS

VILLAGE OFFICIALS' REPORTS

Mayor Scott—Mayor Scott stated that the Street Department would be taking down the Christmas tree this week. The Utilities Committee will be starting mid-February and will be meeting every two weeks for several months. He reviewed the list of potential Zucchinifest entertainers.

Mayor Scott called a special Council meeting to be held on February 6th at 9:00 AM at the Government Center to discuss short and long term capital projects and Zucchinifest entertainers.

Eve M. Ellinger, Law Director – Ms. Ellinger stated that there were two new hires through Obetz jobs. Michael Confer, Police Chief—Chief Confer stated that there were 638 calls for service since the last Council meeting. Hamilton Township Fire Department—Chief Shillingburg commented on the recent article in the Columbus Dispatch. He stated that Obetz does not have a problem with heroin overdoses. He further stated that the Fire Department is working on getting donations to purchase smoke detectors that can be distributed to the community.

E. Rod Davisson, Administrator—Mr. Davisson did not have any additional comments. At the next meeting he will have a presentation for Council.

OLD BUSINESS

NEW BUSINESS

Mary Cutler, resident at 2395 Maureen Boulevard South, addressed Council regarding her water bill. She stated that she lives alone. She did not receive a water bill in October. She called in November to discuss a late fee and was told that there would be no late fee. Her next bill was \$147. She contacted the Water Department and Jon Davis looked at her property and could not find a leak. The next day Marty Ryan found a leak approximately five feet from the new meter. She stated that she had no issues with her line until the new meter was installed. This month her bill was \$324. She had to get the leak fixed two days before Christmas and due to the time of year the cost to repair the leak was \$1100. Mr. Davisson stated that the leak is not Obetz' responsibility and the Village has given her a full leak credit. Mr. Davisson stated that the Village could split the cost of the repair with the resident and credit her the cost of the water that was used if the Village feels that the leak may have been caused by the installation of the new meter. Mayor Scott called for a motion to split the cost of the repair with the resident and provide a full credit for the cost of the water. Motion made by Mr. Richardson; seconded by Mrs. Wiley. Voting as follows: Mr. Wiley—yes; Mr. Richardson—yes; Mr. Flaherty—yes; Mrs. Crabtree—yes; Mrs. Kirk—yes; Mrs. Wiley—yes.
