AN ORDINANCE ADOPTING OBETZ CODE SECTION 1301.17 REGARDING THE REQUIREMENT FOR A FOUNDATION OR SLAB

WHEREAS, it is necessary to update the Building Department regulations to ensure that roofs over decks, existing decks that may be converted to a screened-in porch, and factory built three season rooms are built in a way that ensures that they are safe; and,

WHEREAS, without a foundation or slab, converting a deck into a three season room may not be safe if the deck cannot handle the additional load.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:

<u>Section 1:</u> Section 1301.17 of the Codified Ordinances of the Village of Obetz is hereby adopted to read as follows:

1301.07 FOUNDATION OR SLAB REQUIRED; CONVERSION OF DECKS TO SCREENED IN PORCH OR THREE SEASON ROOM

- (a) All new structures with the exception of accessory structures shall have a continuous foundation or shall be constructed on a monolithic slab unless otherwise approved by the Chief Building Official.
- (b) Roofs constructed over decks shall be independent of the deck unless the Chief Building Official can determine that the deck can handle the additional load.
- (c) An existing deck may be converted to a screened in porch with permanent screens and no windows provided the Chief Building Official determines that the deck can handle the additional load.
- (d) A three season room that is unheated and separated from the principal structure by a solid door may only be constructed on a deck if the Chief Building Official determines that the deck can handle the additional load.

Section 2. This Ordinance shall take effect at the earliest time permitted by law.
