REGULAR MEETING OF NOVEMBER 14, 2016

The Obetz Village Council met in regular session on November 14, 2016 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Mayor D. Greg Scott presiding.

ROLL CALL

Mayor Scott called the roll with six members of Council present: Mrs. Bonnie Wiley, Mr. James Wiley, Mr. Guiles Richardson, Mr. Michael Flaherty, Mrs. Louise Crabtree, and Mrs. Angela Kirk. Also present were E. Rod Davisson, Village Administrator; Michael Confer, Police Chief; Stephen J. Smith, Esq., and Stacey Boumis, Clerk of Council.

APPROVAL OF MINUTES

Tim Kraft from the Auditor of State's Office presented Obetz with the Auditor of State Award with Distinction for Financial Reporting. Mr. Kraft stated Obetz was the only Village in Ohio to receive this award.

Ms. Boumis read Ordinance 71-16: An Ordinance To Approve The 2017 Permanent Appropriations Of All Funds For The Current Expenses And Other Expenditures Of The Village Of Obetz.

Ms. Boumis read Ordinance 72-16: An Ordinance Authorizing The Mayor To Distribute A One-Time Bonus To All Current Village Employees And Declaring An Emergency. Mayor Scott stated this is the same amount as last year.

THIRD READINGS

Ms. Boumis read Ordinance 69-16: An Ordinance Canceling The Regularly Scheduled Council Meetings Of November 28, 2016 And December 26, 2016 And Declaring An Emergency. Mr. Davisson stated that Council is required to have twenty-two meetings a year. Mayor Scott called for a motion to adopt Ordinance 69-16. Motion made by Mrs. Wiley; seconded by Mr. Wiley. Ms. Boumis read Ordinance 74-16: An Ordinance To Accept The Donation Of 2268 Maureen Boulevard From The Central Ohio Community Improvement Corporation And Declaring An Emergency. Mr. Davisson discussed the Ordinance. He stated that the Central Ohio Community Improvement Corporation takes control of abandoned properties and then transfers them to the Village for redevelopment. Mr. Davisson stated that the Village has had more development than planned this year. The payment is to cover sewer tap fees since the sewer system is controlled by Columbus. Mr. Davisson stated that approximately 2.5 million dollars of infrastructure is needed to make this development happen. The Village would be able to get a \$500,000 loan from the Franklin County Infrastructure Bank. Mayor Scott called for a motion to suspend the rules regarding the adoption of Ordinance 76-16.
