# **REGULAR MEETING OF NOVEMBER 13, 2017**

The Obetz Village Council met in regular session on November 13, 2017 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Mayor D. Greg Scott presiding.

## **ROLL CALL**

## **ORDINANCES**

#### FIRST READINGS

Ms. Boumis read Ordinance 61 - 17: An Ordinance To Approve The 2018 Permanent Appropriations Of All Funds For The Current Expenses And Other Expenditures Of The Village Of Obetz.

### SECOND READINGS

Ms. Boumis read Ordinance 54 - 17: An Ordinance Canceling The Regularly Scheduled Council Meetings Of November 27, 2017 And December 26, 2017 And Declaring An Emergency. Ms. Boumis read Ordinance 58 - 17: An Ordinance Extending The Guarantee Period Of Community Reinvestment Area No. 1, And Declaring An Emergency. Mr. Davisson discussed the Ordinance. He stated that this is the Village's largest Community Reinvestment Area (CRA). The CRA is about to expire. The Ordinance allows it to continue. The CRA is an important development tool. Development is a competition and the Village needs this CRA. If the Village does not play the incentive game it will die.

Mayor Scott – Mayor Scott discussed the Christmas Kick-Off on December 9<sup>th</sup>. Council and Mayor Scott determined that the tree should be lit after Thanksgiving and it was okay to light it prior to the Christmas Kick-Off.

Michael Confer, Police Chief — Chief Confer stated that since the last meeting there have been 1,032 calls for service. Mayor Scott stated that he wants a cruiser on Groveport Road in the mornings.

Stacey Boumis, Community Services Director — Ms. Boumis stated that the Village sent the Mid-Ohio Regional Planning Commissions (MORPC) two letters of support recently for grant applications. She also stated that the Village has been actively participating in the Rickenbacker Airport's plan for the area inside the fence as well as the MORPC plan for the larger area. She also stated that there will be a Planning and Zoning Commission meeting in December.

Thaddeus Boggs, Esq., Law Director – No report.

E. Rod Davisson, Administrator – Mr. Davisson discussed the Village's economic development activities and successes. This year the Village created 937 new full-time jobs. The Village's income tax revenue collected continues to increase.

Mrs. Wiley stated that more lighting is needed near the entrance of the Fortress.
