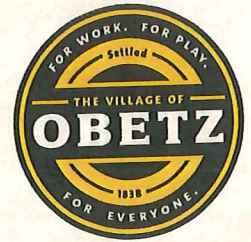

ORDINANCE: 01 - 17

PASSED: January 9, 2017

**AN ORDINANCE TO PAY THELMA COOK A RETIREMENT BONUS TO COVER MEDICAL EXPENSES, AND TO DECLARE AN EMERGENCY**

**WHEREAS**, Thelma Cook retired on December 31<sup>st</sup>, 2016 after faithfully served the Village of Obetz community for 17 years; and,

**WHEREAS**, due to her age, Thelma Cook was eligible for Medicaid and therefore not allowed to enroll in the Village sponsored Health Savings Account (HSA); and,

**WHEREAS**, Thelma Cook had to enroll in the Village's HRA as an alternative; and,

**WHEREAS**, the Village contributes \$4,500 towards the \$5,000 family deductible associated with the Village's HRA program which leaves a difference of that Thelma Cook must cover since her medical expenses have exceeded the \$4,500 contribution for the first time in her career since being in the HRA program;

**WHEREAS**, the Village desires to pay Thelma Cook a retirement bonus that is meant to supplement her HRA account;

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO THAT:**

Section 1. Council authorizes the Finance Director to make a payment of \$768.66 as a retirement bonus to Thelma Cook as a token of appreciation for her dedicated service to the Village and its citizens.

Section 2. This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, welfare and safety and for the further reason that Council desires to pay the funds as close to Thelma Cook's retirement date as possible; WHEREFORE, this Ordinance shall take effect and be in force from and after its passage.
