

## VILLAGE OF OBETZ RECORD OF ORDINANCES

ORDINANCE: 12 – 17

PASSED: February 27, 2017

AN ORDINANCE TO APPROVE THE 2017 WALNUT CREEK CAPITAL IMPROVEMENT FUND AND CURRENT YEAR APPROPRIATIONS FOR THE FUND AND DECLARING AN EMERGENCY

WHEREAS, the Village Council authorized the sale of bond anticipation notes, Ordinance 08-17, for infrastructure improvements and land purchase; and,

WHEREAS, Section 5705.09(E) of the Ohio Revised Code requires a special bond fund for each bond issue; and,

WHEREAS, Section 5705.09(C) of the Ohio Revised Code requires a bond retirement fund, for the retirement of serial bonds, notes, or certificates of indebtedness, and Obetz currently has a fund for LTGO indebtedness;

WHEREAS, Council must approve appropriations prior to expenditures,

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:

<u>Section 1.</u> The 2017 Walnut Creek Capital Improvement Fund is created to account for the proceeds from the sale of bond anticipation notes.

<u>Section 3</u>. To provide for the retirement of the bonds, sufficient monthly deposits shall be made to the General Obligation Debt Service Fund.

Section 4. This Ordinance is hereby declared to be an emergency measure, the immediate passage of which is necessary for the preservation of the health, safety and welfare of the citizens of the Village of Obetz, such emergency arising from the immediate need to comply with the Ohio Revised Code; WHEREFORE, this Ordinance shall take effect and be in force immediately upon its passage.
