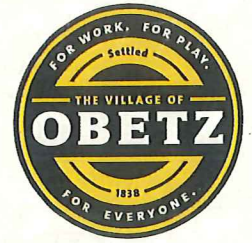

ORDINANCE: 29 – 17

PASSED: June 26, 2017

**AN ORDINANCE TO APPROVE CHANGES TO THE 2017 APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF OBETZ AND TO CREATE THE TOY ROAD 629 GRANT FUND**

**WHEREAS**, Ordinance Number 71-16 approved the 2017 appropriations for the current expenses and other expenditures of the Village; and,

**WHEREAS**, changes to the 2017 appropriations are required for the payment of certain obligations and a reduction of appropriations is needed to meet statutory requirements or to better account for appropriation needs; and,

**WHEREAS**, a new fund is needed in order to track a 629 grant received from the State of Ohio;

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:**

Section 1. The following funds are hereby appropriated/(unappropriated):

Section 2. The Toy Road 629 Grant Fund is created to account for the money received from the State of Ohio to reimburse the Village for a portion of the work done at Toy Road.

Section 3. The Finance Director shall certify these changes to appropriations with the Franklin County Budget Commission.

Section 4. This Ordinance shall take effect and be in force from and after the earliest period allowed by law.
