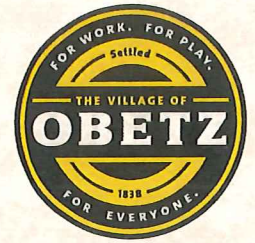

ORDINANCE: 35 – 17

PASSED: August 14, 2017

AN ORDINANCE TO APPROVE CHANGES TO THE 2017 APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF OBETZ

WHEREAS, Ordinance Number 71-16 approved the 2017 appropriations for the current expenses and other expenditures of the Village; and,

WHEREAS, changes to the 2017 appropriations are required for the payment of certain obligations and a reduction of appropriations is needed to meet statutory requirements or to better account for appropriation needs;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:
