**REGULAR MEETING OF JUNE 27, 2016**

The Obetz Village Council met in regular session on June 27, 2016 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Council President Pro-Tem Louise Crabtree presiding.

**ROLL CALL**

Mrs. Crabtree called the roll with six members of Council present: Mrs. Bonnie Wiley, Mr. James Wiley, Mr. Guiles Richardson, Mr. Mike Flaherty, Mrs. Louise Crabtree, and Mrs. Angela Kirk. Also present were Michael Corbitt, Assistant Administrator; Brian Jeffers, Police Sergeant, Stephen Smith, Law Director, and Stacey Boumis, Community Services Director/Clerk of Council.

Mrs. Crabtree called for a motion to excuse Mayor Scott. Motion made by Mr. Richardson; seconded by Mrs. Wiley. Voting as follows: Mr. Wiley—yes; Mr. Richardson—yes; Mr. Flaherty—yes; Mrs. Crabtree—yes; Mrs. Kirk—yes; Mrs. Wiley—yes.

**APPROVAL OF MINUTES**

Mrs. Crabtree called for a motion to approve the minutes of the June 13<sup>th</sup> Council meeting. Motion made by Mrs. Wiley; seconded by Mrs. Kirk. Ms. Boumis read Ordinance 50-16: An Ordinance Adopting Chapter 925 Of The Codified Ordinances Related To Right Of Way Use.

**THIRD READINGS**

Ms. Boumis read Ordinance 47-16: An Ordinance Modifying E. Rod Davisson's Employment Agreement. Mrs. Crabtree stated that Mr. Davisson will get a 2% salary increase and a five year contract extension. No questions. Mrs. Crabtree called for a motion to adopt Ordinance 47-16. Motion made by Mr. Richardson; seconded by Mr. Flaherty. Voting as follows: Mr. Wiley—yes; Mr. Richardson—yes; Mr. Flaherty—yes; Mrs. Crabtree—yes; Mrs. Kirk—yes; Mrs. Wiley—yes.

Ms. Boumis read Ordinance 49-16: An Ordinance To Adopt The Tax Budget For The Village Of Obetz, Ohio For The Fiscal Year Beginning January 1, 2017 And To Submit The Same To The Franklin County Budget Commission And Declaring An Emergency. Mrs. Crabtree opened the public hearing. She stated that the tax budget is done yearly and submitted to the County Auditor in order for the Village to collect property taxes. The Village collects 1.7 mils. No questions. Mrs. Crabtree closed the public hearing. Mrs. Crabtree called for a motion to adopt Ordinance 49-16. Motion made by Mr.

Richardson; seconded by Mrs. Wiley. Voting as follows: Mr. Wiley—yes; Mr. Richardson—yes; Mr. Flaherty—yes; Mrs. Crabtree—yes; Mrs. Kirk—yes; Mrs. Wiley—yes.

**VILLAGE OFFICIALS' REPORTS**

*Brian Jeffers, Police Sergeant*—Sergeant Jeffers stated that between June 8<sup>th</sup> to June 26<sup>th</sup> there were 186 dispatch runs and 448 pick-up runs. There were five misdemeanor arrests; 7 speeding citations; and 6 parking citations. Mrs. Kirk stated that residents were complaining on Facebook about fireworks being discharged in the Village. The biggest issue was that it was after 11:00 PM.

*Mike Corbitt, Assistant Administrator* – Mr. Corbitt stated that Amazon hired 400 people in two days. The Alum Creek Drive/Toy Road intersection is under construction. There will be two turn lanes onto Toy Road from southbound Alum Creek Drive.
