## **REGULAR MEETING OF OCTOBER 10, 2017**

The Obetz Village Council met in regular session on October 10, 2017 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Mayor D. Greg Scott presiding.

# **ROLL CALL**

Ms. Boumis called the roll with all six members of Council present: Mrs. Bonnie Wiley, Mr. James Wiley, Mr. Michael Flaherty, Mr. Guiles Richardson, Mrs. Louise Crabtree, and Mrs. Angela Kirk. Also present were Mayor D. Greg Scott; Michael Confer, Police Chief; Stephen J. Smith, Jr. Esq., Law Director, Stacey Boumis, Community Services Director, and Michael Corbitt, Deputy Administrator.

## **APPROVAL OF MINUTES**

Mayor Scott called for a motion to approve the minutes of the September 25, 2017 meeting. Motion made by Mrs. Kirk; seconded by Mr. Wiley. Voting as follows: Mrs. Kirk—yes; Mrs. Wiley—yes; Mrs. Crabtree – yes; Mr. Flaherty – yes; Mr. Richardson – yes.

## **ORDINANCES**

## FIRST READINGS

Ms. Boumis read Ordinance 48 - 17: An Ordinance To Modify The Final Plat For Bixby Grove Section 3 Phase 1 To Correct The Spelling Of Glasgow Drive.

Ms. Boumis read Ordinance 49 - 17: An Ordinance Authorizing The Mayor To Distribute A One-Time Bonus To All Current Village Employees And Declaring An Emergency.

Ms. Boumis read Ordinance 50-17: An Ordinance Submitting Recommendations Of The Tax Incentive Review Council Regarding Several Village Tax Incentives And Declaring An Emergency.

Ms. Boumis read Ordinance 51-17: An Ordinance Adopting The Solid Waste Management Plan For The Solid Waste Authority Of Central Ohio. Ms. Boumis discussed Ordinance 51-17. She stated that the Solid Waste Authority of Central Ohio (SWACO) was updating its Solid Waste Management Plan (the Plan). This is a regulatory document overseen by the Ohio Environmental Protection Agency whose purpose is to reduce the reliance on landfills and to manage the solid waste generated in Ohio. The Plan describes waste reduction and diversion programming that will be undertaken by SWACO in order to meet State goals. SWACO had to demonstrate that there will be at least ten years of landfill capacity remaining. The current landfill has at least twenty-two years of life remaining. In accordance with Ohio law, Obetz is a part of SWACO's District and therefore Council must pass an ordinance accepting the Plan.

## **SECOND READINGS**

Ms. Boumis read Ordinance 44 - 17: An Ordinance To Remove Section 1361.06(O) Of The Codified Ordinances Related To The Condemnation Reversal Permit. Mayor Scott discussed Ordinance 44 - 17.

He stated that the process is not needed. If someone wants to rehabilitate a condemned property, the individual can apply for building permits.

## **VILLAGE OFFICIALS' REPORTS**

Mayor Scott – Mayor Scott stated that he attended the Ohio School Board Association's Central Region Fall Conference dinner on September 27<sup>th</sup>. Obetz was recognized as a Friend of Public Education for the work Obetz does with the Hamilton Local School District. Mayor Scott further stated that the Ohio Machine has moved their offices to Fortress Obetz.

Michael Confer, Police Chief — Chief Confer stated that since the last meeting there have been 770 calls for service. One semi-truck was issued a ticket.

Captain Wilburn, Hamilton Township Fire Department – Captain Wilburn stated that the Fire Department was testing hoses at the Fortress the other day. Annual testing of hoses is required. He further stated that Leave a Mark Church was having a fall festival on October 28<sup>th</sup> that includes fireworks.

Stacey Boumis, Community Services Director – Ms. Boumis reminded everyone that the Planning and Zoning Commission meeting is tomorrow.

Stephen J. Smith, Esq., Law Director – Mr. Smith stated that the quarry hearing has been moved to November due to Rod's absence.

Michael Corbitt, Deputy Administrator – Mr. Corbitt updated Council on the progress at Walnut Creek. He also stated that the owner of the Ohio Machine was here today and impressed with the Fortress.
