# **REGULAR MEETING OF MARCH 26, 2018**

The Obetz Village Council met in regular session on March 26, 2018 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Mayor D. Greg Scott presiding.

## **ROLL CALL**

Ms. Boumis called the roll with all six members of Council present: Mrs. Bonnie Wiley, Mr. James Wiley, Mr. Guiles Richardson, Mr. Michael Flaherty, Mr. Robert Kramer, and Mrs. Angela Kirk. Also present were Mayor D. Greg Scott; Michael Confer, Police Chief; Thaddeus Boggs, Esq., Frost Brown Todd; Stacey Boumis, AICP, Community Services Director, and E. Rod Davisson, Esq., Administrator.

## **APPROVAL OF MINUTES**

Mayor Scott called for a motion to approve the minutes of the March 12, 2018 meeting. Motion made by Mrs. Kirk; seconded by Mr. Richardson. Voting as follows: Mrs. Kirk—yes; Mrs. Wiley—yes; Mr. Kramer—yes; Mr. Flaherty—yes; Mr. Richardson—yes.

## PROCLAMATIONS AND PRESENTATIONS

Mark Tyler, Superintendent of the Hamilton Local School District, addressed Council. He stated that he was thankful for the relationship the School District has with the Village. He stated that the relationship the School District has with the Police Department is very special. He stated that the community feels good having police officers at the school. Mr. Tyler discussed ways the School District and Village work together including the Obetz Jobs Council and the creation of the School District's Safety Plan.

Melinda Antell with Waste Management addressed Council. She stated that she is the Village's contract liason and she is excited to be working with the Village.

Attorneys from Ice Miller were present. Mr. Davisson stated that the law firm has been working on a fiber network study for the Village. He stated that companies need fiber. He further stated that he would like to start a fiber utility and start construction of the fiber network. Mr. Davisson discussed how the utility would work. The Village's fiber network would connect to Dublin and Grove City. Obetz would not provide internet service, just the physical infrastructure needed. The construction cost is approximately \$3.4 million dollars. In five years, the Village could realize between \$3 to \$8 million dollars. A new bond is needed to fund construction. Council members, Mayor Scott, and Mr. Davisson discussed the project. Council directed Mr. Davisson to proceed.

#### **EMERGENCIES**

Ms. Boumis read Ordinance 11 – 18: An Ordinance Authorizing The Mayor To Execute Necessary Conveyance Documentation To Transfer Approximately 1.877 Acres, More Or Less, Fee Simple Interest In The Properties Located On Alum Creek Drive And Declaring An Emergency. Mr. Davisson stated that this Ordinance as well as Ordinance 13 – 18 allows Obetz to get a Denny's restaurant. The restaurant will be located next to the Dollar Store on Alum Creek Drive. Following the Easter Egg Hunt Obetz hosted a rugby game between Notre Dame College and Indiana University. Baseball and softball registration is closing but more softball players are still needed. ice rink is closed for the season and that the Fortress is back open. The Ohio Machine held their first tryout for the regular season on Sunday. She further stated that the indoor golf league is in week 10 and that sign-ups for youth baseball and softball are underway. The Fortress held its first Ohio Machine High School Lacrosse Showcase on Sunday. The event showcased ten premier lacrosse teams in Ohio. The Village received very positive feedback from visitors.

Mayor Scott – Mayor Scott stated that the Easter Egg Hunt was a blast. Mr. Kramer stated that he thought the area was a good size for the 7 to 10 year olds. Mayor Scott also reported that the Village's income tax is up 45% over this same time last year.

Mike Confer, Police Chief — Chief Confer stated that since the last meeting, officers have responded to 258 dispatched runs and had 1205 pick-up runs.

Captain Wade Edwards, Hamilton Township Fire Department — Captain Edwards stated that the Township took delivery of the second medic truck and they have applied for a grant to replace the ladder truck. He further stated that the Township has a lot of smoke detectors left to give away.
