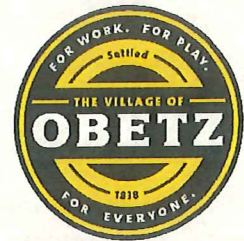

ORDINANCE: 25 – 18

PASSED: June 11, 2018

AN ORDINANCE TO APPROVE CHANGES TO THE 2018 APPROPRIATIONS FOR THE CURRENT EXPENSES AND OTHER EXPENDITURES OF THE VILLAGE OF OBETZ AND AUTHORIZING THE DIRECTOR OF FINANCE TO MAKE A PAYMENT ON A CONTRACT WITH IGS, AND DECLARING AN EMERGENCY

WHEREAS, Ordinance Number 61-17 approved the 2018 appropriations for the current expenses and other expenditures of the Village; and,

WHEREAS, to date, the Village already provided more gas than it had in the previous year, therefore, changes to the 2018 appropriations are required; and,

WHEREAS, IGS provides gas services to the Village of Obetz; and,

WHEREAS, after these serves were rendered, the Village received an invoice for which purchase orders, with prior certification of availability of funds by the Village Director of Finance attached, had been obtained but wishes to reallocate the costs; and,

WHEREAS, Section 5705.41(D)(1) of the Ohio Revised Code provides that in certain circumstances a subdivision may authorize payment on a contract executed without prior certification by the subdivision's Director of Finance; and,

WHEREAS, the Village Council now has before it a certificate from the Director of Finance certifying there was at the time of the making of that contract and at the time of the execution of such certificate, a sufficient sum appropriated for the purpose of such contract and in the treasury or in process of collection to the credit of an appropriate fund free from any encumbrances (a "then and now certificate") and,

WHEREAS, less than thirty days have passed since the Village Council's receipt of the certificate from the Director of Finance;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:

Section 1. The following funds are hereby appropriated/(unappropriated):

Account Number: 5602-523-313-0000

Account Name: Natural Gas

Current Amount: \$580,000

Increase: \$100,000

Revised Appropriation: \$680,000

Section 2. Village Council hereby acknowledges receipt of a "then and now certificate" from the Director of Finance, and authorizes and directs the Director of Finance to reallocate the payment not to exceed the amount of \$18,000.00 to IGS.

Section 3. This Ordinance is hereby declared to be an emergency measure, necessary for the preservation of the public health, safety and welfare, such emergency arising from the need to comply with statutory timelines concerning "then and now certificates"; WHEREFORE, this Ordinance shall take effect and be in force from and after its passage.
