**AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO EXECUTE A THREE-YEAR EXTENSION TO THE EXISTING CONTRACT WITH WASTE MANAGEMENT OF OHIO, INC., AND DECLARING AN EMERGENCY**

**WHEREAS**, Ordinance 90- 15 awarded Waste Management of Ohio, Inc. a contract for residential garbage and refuse waste collection; and,

**WHEREAS**, the current contract with Waste Management Company, a waste management company for residential garbage and refuse waste collection expires on February 28, 2019; and,

**WHEREAS**, the in 2015 the Village solicited trash bids through a Request for Pricing; and,

**WHEREAS**, the contract terms were set at three years with two optional three-year extensions; and,

**WHEREAS**, the Village has been satisfied with the current service offered by Waste Management and desires to continue utilizing Waste Management for its residential garbage and refuse waste collection;

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ, OHIO, THAT:**

Section 1. Council extends the contract with Waste Management of Ohio, Inc. for residential garbage and refuse hauling collection and directs the Village Administrator to execute the same in a form acceptable to the Law Director.

Section 2. The period of the contract shall be from March 1, 2019 through February 28, 2022.

Section 3. The monthly residential refuse rates are as follows:

<u>Begin Date</u>	<u>End Date</u>	<u>Rate</u>
March 1, 2019	February 29, 2020	\$14.00
March 1, 2020	February 28, 2021	\$14.49
March 1, 2021	February 28, 2022	\$15.00

Residents who are 65 years old and older and head of household may apply for a 10 percent discount on the residential refuse rate.

Section 4. This Ordinance shall be declared an emergency necessary to provide for the health, safety, and welfare of the citizens of the Village of Obetz.
