Mr. Davisson stated that this is part of the economic development grant to Retro Concepts LLC for costs related to the State of Ohio's ownership of land. Mr. Smith stated that the State of Ohio has inserted itself into the transfer process and the Ohio Department of Transportation has additional steps that make the transfer process long and difficult. STANDING COMMITTEE REPORTS

VILLAGE OFFICIALS' REPORTS

Mayor D. Greg Scott – Mayor Scott stated that a local business complimented the Village on clean streets. Mayor Scott further stated that it is time to pick entertainment for the Zucchinifest.

Michael Confer, Police Chief — Chief Confer stated that dispatched runs were up 5% over last year and pick-up runs were up 57%. Parking citations were up due to snow. Chief Confer further stated that a lot of speeding tickets have been issued on East Howard Road. Sergeant DeBolt stated that officers have been focusing a few hours each shift on traffic.

Stacey Boumis, Community Services Director – Ms. Boumis provided a summary of the January 9, 2019 Planning and Zoning Commission meeting.

Stephen Smith, Jr., Esq., Law Director - No report.

E. Rod Davisson, Esq., Administrator – Mr. Davisson stated that the Village has closed on McClish South. He reviewed the changed in responsibilities for several employees. He stated that Village purchased a leaf vacuum and leaf pick-up occurred in two neighborhoods before the weather turned. Pot holes have been repaired throughout the Village. Renovations to the old Tata house is underway and the house will be the new home of the Buildings and Grounds Departments. Mr. Davisson stated that the Food Truck Festival date has been set for June 15th in conjunction with an Ohio Machine game. Mrs. Wiley stated that she would like to see a Facebook page for the Police Department. Mr. Davisson responded that he did not want police officers managing something like this.
