## STANDING COMMITTEE REPORTS

Recreation and Health – Mrs. Kirk stated that youth baseball, softball, and t-ball registration is underway. She also reported that the Daddy Daughter Dance was a big hit.

## **VILLAGE OFFICIALS' REPORTS**

Mayor D. Greg Scott – Mayor Scott stated that the Daddy Daughter Dance was a success. He also stated that income tax collections are slightly up over last year.

Ryan DeBolt, Police Sergeant — Sergeant DeBolt stated that Officer Maynard, the Hamilton LSD Resource Officer has been very busy and he has been heavily involved since starting at the school. Sergeant DeBolt stated that officers have increased traffic enforcement on certain streets in response to complaints from residents. As a result, 45 tickets have been written; there have been 13 arrests; and 5 individuals with outstanding warrants have been apprehended.

Wade Edwards, Captain, Hamilton Township Fire Department – Captain Edwards stated that the Board of Trustees has voted to put a ½ mil general fund levy increase on the November ballot.

Stacey Boumis, Community Services Director – Ms. Boumis stated that she is still working on Zucchinifest entertainment.

Yazan Ashrawi, Esq., Frost Brown Todd - No formal report.

E. Rod Davisson, Esq., Administrator – Mr. Davisson discussed the high speed police chase through Obetz over the weekend. Obetz officers are encouraged not to participate. He further stated that the Williams Road offices are almost ready. Mr. Davisson discussed upcoming events and other projects underway. The Zucchinifest entertainment search is underway. The first two country acts discussed are not available. He asked Council for the okay to offer a spot to Scotty McCreery. There were no objections.
