REGULAR MEETING OF MARCH 25, 2019

The Obetz Village Council met in regular session on March 25, 2019 at 6:00 PM at the Obetz Government Center located at 4175 Alum Creek Drive with Mayor D. Greg Scott presiding.

APPROVAL OF MINUTES

ORDINANCES

FIRST READINGS

Ms. Boumis read Ordinance 07 - 19: An Ordinance Approving The Recodification, Editing And Inclusion Of Certain Ordinances As Parts Of The Various Component Codes Of The Codified Ordinances Of Obetz And Declaring An Emergency.

Ms. Boumis read Ordinance 08-19: An Ordinance Accepting the Dedication of (Road Yet to Be Named) As A Public Street And Declaring An Emergency. Mr. Davisson discussed the Ordinance. He stated that this will be the new public road connecting Williams Road to Recreation Trail. Mayor Scott proposed Fortress Way. Council members agreed.

Ms. Boumis read Ordinance 06 – 19: An Ordinance To Rezone 4480 Alum Creek Drive (Parcel Number 186-000184) And 4520 Alum Creek Drive (Parcel Number 186-000001) From Restricted Industrial To Planned Commercial District. Mayor Scott opened the public hearing. Ms. Boumis stated that the Planning and Zoning Commission recommended approval of the rezoning. No questions or discussion.
