ORDINANCE: 28 – 19

PASSED: September 9, 2019

**AN ORDINANCE TO ACCEPT THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR AND DECLARING AN EMERGENCY**

**WHEREAS**, this Council in accordance with the provisions of law has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1, 2020; and,

**WHEREAS**, the Budget Commission of Franklin County, Ohio has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within, the ten mill tax limitation.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OBETZ THAT;**

Section 1. The amount and rates as determined by the Budget Commission in its certification be and the same are hereby accepted.

Section 2. There be and is hereby levied on the tax duplicate of said Village the rate of each tax necessary to be levied within and without the ten mill limitation for tax year 2019 (collection year 2020) as follows:

Section 3. The Clerk be and hereby is directed to certify a copy of this Ordinance to the County Auditor of Franklin County.

Section 4. This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, welfare and safety and for the further reason that there exists the immediate necessity to accept the amounts and rates determined by the Budget Commission in order to continue collecting taxes; WHEREFORE, this Ordinance shall take effect and be in force from and after its passage.
